### Brother James Brogdon Hilderbrand An Episcopal President

He was born in Cameron, SC, one of ten children of the late Reverend Benjamin S. Hildebrand. He attended Lincoln High School in Sumter, SC. He earned his undergraduate degree from South



Carolina State College. In Orangeburg, SC with a degree in horticulture, he obtained his master's degree from Penn State University in Educational Administration. His teaching career began in 1949 at Wilkerson High School, Orangeburg, SC. He was a veteran of World War II.

Brother Hilderbrand was a member at Campbell Chapel AME Church In Bluffton, SC.

Brother Hilderbrand served as one of the church's stewards at Campbell Chapel.

He was employed as a principal at Michael C Riley School in the fall of 1965. He began teaching Agriculture at Bluffton Grade School in 1953. Before his principalship in 1970, the schools in Bluffton were fully integrated and reorganized. MC Riley became an elementary school and Bluffton High School served as the lone high school. He became the principal of the elementary school and served until 1984. At the time of his retirement, he had completed 33 years in the field of education. He also served as Mayor Pro-Tem for the Township of Bluffton. A street is named in his honor, 'Hildebrand Dr.' which was parallel to the old MC Riley site.

### Brother James B. Hildebrand served as president of the Seventh District Lay Organization from 1979-1987.

He ran and was elected president of the SEDLO in 1979. The election was held in the Columbia Conference at Bethel AME Church, which was located on Taylor Street at the time. When he ran, two other people ran for the same position. When Brother Hilderbrand was elected and installed as president, Bishop Frank M. Reid II, was the Bishop of the Seventh District, and his son Rev. Frank M. Reid III preached the Installation Service.

He was a member of the Hildebrand family. He was the brother of the late Bishop Richard Allen Hildebrand. Bishop Hildebrand was the 88th elected Bishop of the AME Church. Most of his brothers were either preachers or Presiding Elders. The Hilderbrand name dominated the General Conferences for years; however, nothing lasts forever.

Brother Hildebrand's style of leadership and past president JT Mims style of leadership were similar in that they both were educators.

Even though Brother Hildebrand's siblings were ministers, he was a lay person. The 7th District leadership did not see him as a rebel lay leader. Brother Hildebrand won the lay organization election with the help of the late President Elizabeth Northerner of the Edisto District Lay Organization. Along with the South Carolina Conference Lay Organization, they were able to bring out the numbers.

When Brother Hildebrand became president, he changed the meeting format of the State's Lay Organization Meeting. It was a day's event closing out the next day. What was done on Friday was the business session

Friday night, a big banquet and Saturday morning closing with the Episcopal leader preaching.

What separated both men was the time between them. Brother Hildebrand was now the person for a new time.

What Brother Ralph James did was summarize some of the qualities of Brother James Hildebrand's leadership.

He offered respectful leadership.

He offered staple leadership.

He was respected by the clergy.

Also, he was respected by the lay members of the district.

His style of leadership offered the organization an opportunity for growth.

This made for great recruitment because everyone wanted to be a part of something that looks great

The outgoing Brother Hildebrand offered to the new President Ralph James to be prompt to have a plan;

- · staying in touch with all of the church entities
- having an agenda to get everyone involved with the plan as my conversation with Brother Ralph James ends, the downside was that Brother James Hildebrand died two years after his tenure as president ended, but he felt blessed to have known him for that time.

Brother James Hildebrand was born September 3, 1919, and died September 2, 1989. He was married to the Late Carrie Wright Hilderbrand; they raised two foster sons.



## Local President Sister Valarie Frasier Kingstree District

Sister Valarie Frasier is the President of the Lay Organization at St. Peters AME Church in the Kingstree District of the Palmetto Conference. She is also a member of the Steward Board, a member of one of the choirs, and teaches Sunday School

at her church. Sister Frasier is married to Brother Cleveland Frasier, and they have five children, nine grandchildren, and one great-grandchild.

Sister Frasier also served as president of the local Lay Organization at Bethel AME Church in Ravenel in the Edisto District and of the South Carolina Annual Conference. When Sister Frasier served as president at Bethel AME Church, Brother Leroy Lenin was the president of the Edisto District Lay Organization. Sister Frasier credits Sisters Green and Nedd for their support and influence on her when she was a local president in the Edisto District.

Sister Frasier felt that she was elected because of her eagerness to learn about the AME Church. President Leroy Linen appointed her to chair a Baby Contest Committee during her time in the Edisto District. At the end of the fundraising event, she thought it was extraordinarily successful, and THE CONTEST raised over \$2,000.00.

She would later move her membership from Bethel AME Church in Ravenel to St. Peters AME Church. Sister Frasier is currently the local president of the Lay Organization of this church. Since moving to the Kingstree District.

He then organized Bethel's first Lay Organization and served as its president. He faithfully served in this position and represented Bethel Church at District, Conference, Annual, and General Conferences.

Bro. Spell functioned as the Lay voice of the Charleston District for 10 years. Additional persons who worked with Bro. Spell and Bro. Cato and the Lay Organization. They were: Sis. Carrie Aiken, Sis. Emily Alston, Sis. Florine Gladden, Sis. Edna Noisette, Sis. Madeline Reed, Bro. Wickman Reed and Sis. Magnolia Thomas all of Bethel Summerville, Bro. Jacob Banks and Isaiah Brown of St. Paul Harleyville, Mrs. Rachel Jenkins of Mt. Zion Harleyville, Mrs. Bertha Lisbon of Bethel Holly Hill, and Bro. Ralph James from Bethel St. George. Bro. Ralph James was often seen with Bro. Spell and spoke on his behalf on several occasions. The voice of the laypeople became stronger and stronger. The laypeople began to articulate the intricate circles of the African Methodist Episcopal Church. Regular meetings took place and interest in serving was being expressed by others from the ranks of the laity.

## Sis. Delores F. James Past local President Bethel AME Church



Sis. Delores James was elected Lay President in the Conference year 1990 under the pastorate of Rev. Joseph Myers. The following officers were elected to serve and installed by President Ralph James of the South Carolina Conference:

Lay persons of Bethel attended the District, Conference, and Episcopal meetings and voted in the elections of the Lay Organization on all levels. The annual program "Laymen in Royal Blue and White" with worship and praise headed by a member from

the different organizations of the church testifying and followed by "Tag Team Preaching" by guess ministers and the "Penny -O -Meter Project" (collection of pennies for the college student fund). The Budget asking at this time was \$300 per year. Sis. Delores James funded and represented Bethel at the Charleston District Meetings, South Carolina Conference Lay Meetings, State Lay Conventions, and the Lay Biennial Conventions that were held in Washington, D.C., Philadelphia, Oklahoma, South Carolina, Florida, Alabama, Ohio, and Texas.

The speaker for the Lay Day program was the President from the District, Conference, or Episcopal levels of the Lay Organization.

I understand that this magazine aims to highlight the accomplishments of past leaders. However, I believe that my story is also important and deserving of recognition. If it is not shared now, it might never be told.

From the very beginning of my presidency, I have been learning valuable lessons in leadership within the AME Church. My commitment to our organization remains unwavering.

#### **Lessons Learned**

I began attending several district meetings and discovered that the district operated on a two-year budget cycle. Inspired by this, I aspired to implement a similar approach in our organization. However, I was informed that we did not need a budget as our organization did not pay one. Recognizing that their tenure was nearing its end, I decided to wait patiently.

Material Accessibility: When materials were needed to advance our meetings, I
was instructed to come to the church to make copies. This presented a challenge as
I did not possess keys to the church or office. Despite this, I found ways to
overcome this obstacle and successfully obtained the necessary materials.

I encountered several challenges, but I was able to navigate around each one effectively.

- I know that I am an observer at any meetings above the district unless I hold a committee chairperson role.
- I am deeply grateful for the opportunity to lead and serve in our local Lay Organization at White Hall.

### Gil Alpha Walker President of Greenville District

Born January 27, 1957 – Died May 6, 2012



Gil was educated in the Pickens County South Carolina school system and graduated from D.W. Daniel High School in Central, South Carolina.

He furthered his education by attending Forrest Junior College in Anderson, South Carolina.

Gil worked with Duke Power and Nutra Manufacturing.

Gil was a member of King's Chapel AME Church in Pendleton, South Carolina where he held numerous titles such as Church School Teacher, Chairman Pro Tem of the Trustee Board, Christian Education Director, and President of the local Lay Organization. Other boards and auxiliaries to which he belonged included the Commission on Stewardship and Finance, the Church School Department, Resource Center staff member, the Sons of Allen, the Senior Choir, the Gospel Choir, the Men's Choir, which he organized, and the Women's Missionary Society (WMS).

Gil was also very active at the Greenville District and Piedmont Conference levels of the Seventh Episcopal District of the AME Church, serving as the Greenville District Lay Organization President, member of the Piedmont Conference Lay Organization (his love for the church and his desire for the AME community to be trained and to be loving Christians inspired him to become involved with the Lay Organization), member of the Richard Allen Banquet Committee, member of the Greenville Area Women's Missionary Society, and a member of the Piedmont Conference Women's Missionary Society, where he was named "Mr. Missionary" for his involvement and works. He often traveled across the state for various meetings, conventions, and annual conferences.



#### The Church Facing Evil in 2015

I attended a meeting called by the Right Reverend Richard Franklin Norris Bishop of the Seventh Episcopal District to pray and talk about the shootings of nine AME members. This meeting took place in the Palmetto Annual Conference of the Mt. Pleasant District and Morris Brown AME Church was the host site. This church is also named after one of the bishops of the faith. There was standing room only as our Episcopal leaders discussed the terrorist attack on the denomination. Similar meetings were scheduled in several other places across the state of South Carolina.

Bishop Norris couldn't attend, because he had just received an organ transplant. Attending this meeting would have placed his health in jeopardy. He, I think, did a lot of the organizing efforts from his office. In addition, a video was shown on the site of the Seventh Episcopal District in which he is speaking to Episcopal District and letting the membership and the world know that we would not give in to fear and that we are still a praying church.

I attended this meeting because I wanted to hear firsthand how the Seventh Episcopal District leadership was handling these events as we move forward. I was quite impressed with the numbers of news organizations that were covering this first meeting, which was held at Morris Brown AME Church.

Four of the bishops of the faith were present during this meeting. They all shared that this attack will not make us weak, but will cause us to be stronger. The church doors will not be closed nor will we give up. I could identify leaders of other faiths present in addition to leaders from the AME Church. Business and political leaders were also at the gathering. All of the leaders were given a time to make comments.



One of the Presiding Elders prayed that the community would heal and that God would keep the church family under his protection.

< Elder Novell Goff Presiding Elder of the Edisto District informed us that the lone killer had been caught. While this is a part of the healing process, there is still a long way to go.



Congressman James Clyburn our congressman brought us a message from the President of the United States. It was a message of hope to families. He said the black church is the rock in our communities. The church is also built upon a rock; no acts of terrorism will move this rock. He quoted from a letter that the late Dr. Martin L. King, Jr. wrote while sitting in a jail during the struggle for equal rights: "in the end, we will remember not the words of our enemies, but the silence of our friends."
